Eligibility

Winter Park Alpine ArtAffair is open to
artists who will be present to exhibit
work of their own concept, design
and execution. The show is juried to
ensure overall quality and balance,
with preference given to work reflect-
ing the greatest degree of originality,
creativity and craftsmanship. **No
manufactured, commercial, imported
or kit work** will be considered or per-
mitted. Only merchandise of artists
juried and accepted by the Alpine
ArtAffair Jury will be allowed. Approx-
imately 90 artists will be accepted.
Each artist participant must attend
his/her booth and is responsible for
insurance and sale of his/her artwork.

Exhibit Space

Assigned booth space is 10'x10'. Space
only is provided. Each artist will provide his/
her own display and equipment. All parts
of the display must fit within the limits of
the assigned area.

The outdoor grounds are nestled in pine
trees along US Highway 40 in Winter Park-
elevation 9,000 ft. Conditions vary from
flat to slightly rough. Because the show is
held outside, suitable protection from sun,
wind, and rain is suggested. There is no
rain date. Booth space may be shared if
both artists have paid jury fees and have
been accepted. Double booth space
(\$250) may be purchased, if available.

**Booth Sitters on Site During Show Hours.
No Commission on Sales is Charged.
Overnight Security is NOT provided.**

Slides/Digital Photos

Submit a maximum of four **digital** photos
via CD or email **or** four slides of **current**
work. CD/Slides **must be labeled with
name of artist** and be in good condition.
Photos should be a good representation
of each medium applied for. Please do
not send samples of your work.

Sales Tax

Municipal, County, and State Taxes (total
8.9%) will be collected from each artist.
An ArtAffair official will collect your taxes
on Sunday afternoon and forward on your
behalf to the Colorado Department of
Revenue and the Town of Winter Park.

Please be prepared to pay sales tax with
check or cash.
